BITS & PIECES OF LEGISLATIVE NEWS

Early in February Governor Kasich rolled out his proposed budget for the next two years. I am sad to say that Education again seems to be the last thing on his mind as funding for many school districts would be reduced. I have included excerpts from two articles that were printed in the Columbus Dispatch.

Buried in the budget proposal is a requirement that teachers participate in an externship as part of their license renewal. The Local Professional Development Committees (LPDC) in each district would implement this should it be approved. This is exactly what teachers need - less free time and more requirements! No wonder the profession will be looking at a teacher shortage in the not so distant future. I have also included a short article from NBC News in Columbus. The budget must be approved by the State Legislature by July 1, 2017.

A new Right to Work bill has been introduced in the House in Columbus by Representative John Becker, (R) of Cincinnati. If passed, this would be devastating to the unions and the effects could trickle down to us as retired members. It would be the gateway to other anti-union legislation. The Governor has said that he is not interested in this since the overwhelming defeat of Senate Bill 5 in 2011. We will see.

New data shows even more districts would lose under Kasich's school-funding plan Governor John Kasich rejected the notion that \$5 billion in tax cuts on his watch have deprived the state of money that could have been used to benefit public schools and other services.

Governor Kasich's proposed biennial budget has mixed messages for school districts in Ohio. It includes a small increase in funding but does not return the \$500,000,000 still left on the table from his budgets in 2013 and 2015. As additional data provides a more complete picture of Gov. John Kasich's school funding plan, it turns out more districts than initially revealed would see funding cuts.

When the Kasich administration released spreadsheets last week (Feb. 8) detailing how this budget proposal impacted individual districts, it did not include the reduction in tangible personal property tax reimbursements that have

A new nonpartisan Legislative Service Commission analysis that included those reimbursements shows that 388 districts would lose funding over two years...49 more than prior data.

The budget also does not include any base per-pupil funding increase, allowing schools with declining enrollment to lose funding, lower transportation funding for some districts, and a declining state-share index that, above all else, is the key to how money is distributed.

Overall, 373 districts saw their state share index drop, meaning the state picks up less of the cost of education, while it rose for 237 districts. Basic operational aid for Ohio schools would grow by 0.7 percent next year, and 1.2 percent in 2019 overall; an increase of about \$155 million over two years.

Ohio budget bill would require teachers to job shadow as part of license renewal By NBC4 Staff (Columbus)

COLUMBUS (WCMH) -Buried more than 1,000 pages into the proposed Ohio 2018-2019 budget bill is a job-shadow requirement for teachers looking to renew their license.

The bill reads, "Beginning September 1, 2018, the state board of education's rules for the renewal of educator licenses shall require each applicant for renewal of a license to complete an on-site work experience with a local business or chamber of commerce as a condition of renewal. Work experience obtained pursuant to this section shall count toward any required continuing education. Each local professional development committee established under section 3319.22 of the Revised Code shall work with its teachers to identify local work experience opportunities that meet the requirements of this section." The section appears on page 1056 of House Bill 49, the state's proposed 2018-2019 fiscal year budget.

MILLY KNEW BETTER

The experts said that plastics couldn't be recycled. A spunky woman proved them wrong. A little-known Wisconsin woman almost singlehandedly created America's plastic recycling industry. Along the way, she became an environmental hero.

It all began with a trip to Japan in 1978. Millie was impressed by Japan's cleanliness. She noticed that each day a different type of waste item was placed on the sidewalk for pickup and recycling. Back home she noticed that tons of plastics were thrown away and contacted county supervisors asking why they did not recycle plastics. The supervisors were cool to the idea because there was no market for the materials.

Millie Zantow and her good friend, Jenny Ehl cashed in their life insurance policies, bought a \$5,000 plastics grinder and started E-Z Recycling, one of the first, if not the first, business of its kind to recycle plastics in the United States. Milk jugs were the first plastics to be recycled with other plastics later. Undaunted, she invented a system to identify different plastics with an imprint of a triangle with a number inside.

In 1988, the coding system was adopted by the Society of the Plastics Industry adopted the coding to identify different plastics, and is now used world wide. Earlier she had sold her company, stating that she had never made a dime from the business. She proved plastics recycling was feasible. Wisconsin's statewide recycling law was signed in 1990 and is considered one of the best in the country.


