MORE STUFF FOR THE INFORMED RETIREE

The following is a summary of the highlights of House Bill 512. This is from an Ohio Education report. This is a "power-grab" from the Kasich Administration.

Kasich Administration Voices Support for Education Consolidation

House Bill 512, sponsored by Representative Bill Reineke (R-Tiffin), seeks to consolidate the Ohio Department of Education, the Ohio Department of Higher Education, and the Governor's Office of Workforce Transformation into a new, cabinet-level agency, the Ohio Department of Learning and Achievement. The bill also proposes to transfer most of the functions and policymaking powers of the State Board of Education (SBOE) to the new department. Under the bill, SBOE would oversee teacher licensure and educator misconduct. OEA is opposed to this bill.

On Tuesday, February 27, 2018, supporters of the bill offered proponent testimony in a hearing before the House Government Accountability and Oversight Committee. The proposal praised by officials from Governor Kasich's administration. John Carey, Chancellor of the Ohio Department of Higher Education and Ryan Burgess, Director of the Governor's Office of Workforce Transformation stated that the bill will lead to greater coordination and collaboration. Among others providing testimony in favor of HB 512 were Dennis Franks, Superintendent of Pickway-Ross Career Technology Center; Ron Iarussil, Superintendent of the Mahoning County ESC; and Tom Gunlock, former President of the State Board of Education.

In opposing the bill in its current form, OEA believes the proposed consolidation of these state departments would dilute the unique roles and needs of each department. OEA is skeptical that the proposed "super" department will promote additional collaboration. OEA is also not convinced that the functions of the preK-12, higher education, and workforce development systems would be adequately carried out under this plan.

Further, OEA is very concerned with the diminished roll of the State Board of Education, Members of the Board serve an important democratic function that allows for public and educator input on K-12 education issues. While we share the stated goal in increased collaboration, OEA believes that the stated objectives for this bill can be achieved without the merger of these state departments.

ECOT used for-profit companies to hide source of attack-ad money, Yost says

Another ECOT SCAM!!!

Using private companies owned by Electronic Classroom Of Tomorrow school founder Bill Lager, plus a media-production company run by his daughter, ECOT tried to hide the source of payment for nearly \$250,000 worth of TV attack ads aimed at the Ohio Department of Education.

That is the conclusion reached by the office of State Auditor Dave Yost, who, in a draft finding for recovery obtained by the Dispatch, lays out details of a plan designed to avoid the appearance that ECOT illegally used taxpayer money to pay for political ads.

As a result, Yost is ordering a pair of Lager's ECOT-affiliated for-profit companies, Altair Learning Management and IQ Innovations, along with Third Wave Communications, where Lager's daughter Jessica Harris is the owner, to repay ECOT a total of nearly \$250,000 for illegally spent public money.

ECOT, formally the state's largest charter school was closed in January. The recovered money would go into a fund that is under the control of an interim master who was appointed by a Franklin County judge; the fund is to be used to continue paying the school's obligations. The companies can formally respond to the finding this week.

Local School Districts Stand to Recover Money Lost to Troubled Charter Schools with the Passage of HB 87

Finally some good news from Columbus. This bill, with passage by the Ohio Senate and signature by Governor Kasich will guarantee that recovered monies collected dishonestly by charter schools will be returned to the home district and not the General or Rainy Day Fund!

HB 87 was passed 94-2 by the Ohio House on March 7, 2018. OEA worked with Rep. Kristina Roegner (R-Hudson) and the bill's bi-partisan co-sponsors to secure overwhelming support for this important charter school financial accountability bill. State Auditor Dave Yost also voiced strong support.

The bill requires any public funds that are reclaimed by the state based on a finding of recovery against a charter school for <u>fraudulently over-reporting enrollment</u> to be returned to the school districts from which the funds were initially deducted. Ohio law is currently silent on where the state should send these recovered funds.

The House passage of HB87 by a vote of 94-2 comes after recently passing stronger charter student residency verification requirements in HB21 (R-Hambley) by a vote of 94-0. HB21 has received three hearings in the Senate Education Committee thus far and is likely to be approved by the Senate.

Department of Education Fail: Teachers Lose Grants, Forced to Repay Thousands in Loans

Another betrayal by this administration attempting to derail Urban Public Education and hurt disadvantaged children!

America needs teachers committed to working with children who have the fewest advantages in life. So for a decade the Federal Government has offered grants worth up to \$4,000 as year to standout college students who agree to teach subjects like math and science at lower-income schools.

A new government study, obtained by NPR and later posted by the Department of Education, suggests that thousands of teachers had their grants taken away and converted to loans, sometimes with minor errors in paperwork. That's despite the fact they were meeting the program's teaching requirements. "Without any notice, [my grant] was suddenly a loan, and interest was already accruing on it." says Maggie Webb, who teaches eighth-grade math in Chelsea, Mass. "So my \$4,000 grant was now costing me \$5,000.

Since 2008, The Education Department has offered these so-called TEACH grants to people studying to get a college or Master's Degree. The deal is, they get to keep the grant money if they spend four years teaching a high-need subject like math or science in schools that serve low-income families.

If they don't keep their end of the bargain, the grants convert to loans that need to be paid back. But, the study finds, many teachers believe they kept their end of the bargain but are now being asked to repay the money anyway.


