I also have held offices with various community organizations and have volunteered in activities within my church and Hospice of the Western Reserve, and then somehow got elected in being your President.


Enough about me, the Board wants to hear from you! Do you have a question about how our association functions, want a clarification on an issue, and/or have an idea for a potential program. If so, email me at

Important Information for All LCRTA Members David Morse

A group of Ohio STRS retirees are pushing for a forensic audit of STRS's financial books and fiscal practices. The audit is being sought because this group of retired educators has questions that they feel have not been answered to their satisfaction. To achieve this audit, that group has asked ORTA to be the fiscal agent for donations that are being requested from other interested STRS retirees. The cost of this audit would be \$75,000.00.

There are two online sites that might give you more information in understanding this venture. The first is the ORTA site: www.ORTA.org. This will provide you with the text of the stated purposes of the requested audit.

The second is a Facebook site that is for STRS members only. To access the site, you must request admission and provide some personal information that proves your STRS status. Within a few days, you will receive the approval and you can peruse the information provided by others who are a part of the Facebook STRS group. By Terri Herbert Beyond Passwords: How to Protect Your Financial Data

Data breaches are becoming more common. And we are all doing more online, especially during this last year. Creating solid passwords for your accounts is just the start of staying safe. Here are some additional tips for protecting your online financial data.

Use Two-Factor or Multi-Factor Authentication

A strong password is your first line of defense. To take advantage of another layer of security to your financial accounts, take advantage of two-factor authentication. This can be anything from a security code texted to your cell phone to a security key required to unlock your computer. According to Consumer Reports you can purchase a physical, bluetooth enabled key for as little as \$20.00.

Change Up Your Usernames

Most people are aware that they should change their passwords on a regular basis (or use a password manager that does it for you). But also pay attention to your usernames. Changing your username from what you use for your email to something more unique will help with improving your online financial security. Try to switch it up at least once or twice a year. Avoid logins you have used in the past.

Keep Your Transactions Private

Many people login on public Wi-Fi when available. But be wary of logging in to your financial accounts when on a public network. The same goes for making transactions on your devices, including entering your credit card number, bank account or other financial information. Always do your financial business from your home.

Secure Your Devices

Always update the operating systems on your smart phone and computers whenever it becomes available. New versions often include additional security patches that help protect your device. Install new operating systems as soon as you can, once they become available. After you complete and update, recheck your privacy settings on your apps and devices to make sure they have remained the same. In addition, consider installing anti-malware software on your devices and keep them updated.

Monitor Your Credit

Keeping a close watch on your credit report allows you to know if your personal information is being used for fraudulent activity.

(Info&Protective)

Your credit report reveals inquiries made about your creditworthiness, as well as accounts opened in your name. Checking at least once a year (or more often) ensures you will spot suspicious activity relatively early. You can receive free copies of your credit report from each of the three major credit reporting bureaus one time per year. So, set one up for every 4 months, varying the bureau.

Online banking and electronic financial transactions have made life easier, but does put your data more at risk. Balance convenience and security to help avoid data breaches, or a least be able to respond to them in a timely manner and limit any damage.

Shame on Ohio Senate for failing kids again William L. Phillis, Guest Columnist

It is a colossal blunder that Ohio Senate leadership blocked the passage of House Bill 305 and Senate Bill 376-The Cupp/Patterson Fair School Funding Plan. The reason given for blocking this intense and accomplished three-year effort are hogwash.

Any fix to the unconstitutional school funding system is complex and hence will not be perfect. Upgrades and adjustments will always be needed as implementation takes place.

Creation of a School Funding Oversite Commission was embedded in the bill to make course adjustments as the plan is implemented and as required in the future by changing demographics and educational demands. The inclusion of this commission, which would provide recommendation to the legislature, should have given the Senate comfort that the plan could be adjusted as needed on a timely basis. To reject the plan with the glib suggestion that it might have some defects is irresponsible. The Ohio Supreme Court ruled the system unconstitutional more than 23 years ago.

By contrast Senate Bill 89, the EdChoice voucher bill, cleared the House and Senate in less than 24 hours. A few years ago, the infamous House Bill 70– a law allowing state takeovers of school districtsmoved through both house chambers of the legislature from introduction to enactment in 24 hours. The Senate had ample time to consider the Cupp/Patterson plan.

The Ohio Constitution requires the state to secure, by taxation, a thorough and efficient system of common schools; hence the funding system must be premised on the components of a high quality education. Those components must be costed out and the distribution system must ensure the school districts have sufficient financial resources to provide the high quality education components identified.

The Cupp/Patterson plan embraces these concepts and, when fully funded, would meet the constitutional mandate. Historically there has been a disconnect between the school funding formula and the educational needs of students. The Cupp/Patterson plan connects the funding formula and distribution system with the components of the high-quality education that Ohio children need. The structure of the plan requires the state to fund high-quality education across the board. Without the structure of this plan, school districts will continue to provide only as much for students as enabled by the politically determined amount of funds received, without regard to student needs.

The plan, thus, requires the totality of the necessary educations and services to drive the funding level. That's how the plan addresses the constitutional requirement the state secure a "thorough and efficient system of common schools" throughout the state.

On March 24, 1997, the Ohio Supreme Court ruled the Ohio's elementary and secondary schools are neither thorough nor efficient. The court identified the factors that contribute to unworkability of the school funding system and must be eliminated. The two primary factors were the operation of the school funding formula and the emphasis of property tax in the formula calculation; the Cupp/Patterson plan corrects those critical defects found by the court.

It should be embarrassing to state officials that Ohio continues to operate a school funding system that the court ruled unconstitutional nearly a quarter century ago. The Ohio Senate should hang its collective head in shame for scuttling a plan to conform the school funding system to the constitutional mandate. *William L. This year email addresses will be added to the yearbook. Many people now correspond by email more often than by phone. Phone numbers will still be included.


