The Ohio Legislature Strikes Again New Meaning to DRACONIAN

Ohio House Bills 322 and 327 have been introduced, which would restrict the teaching of certain concepts and topics in K-16 classrooms. HB322 primarily targets public schools and state agencies, but the Ohio Department of Higher Education would be included under the definition of state agency. This bill prohibits public entities from requiring discussion of current events and prohibits the teaching of a list of topics dealing with race, sex, slavery, and bias. It also targets history and civic courses, discouraging the discussion of current events, controversial issues, and activities that involve social or policy advocacy. Moreover, the legislation specifies that teachers cannot be required to teach anything that goes against their "sincerely held religious or philosophical convictions."

HB327 is slightly different and more punitive than HB322. The bill prohibits public schools, state agencies, colleges, and universities from offering teaching, instruction, or training on "divisive concepts" or accepting private funding to promote such concepts. Violations of the bill would result in the withholding of funding to school districts or State Share of Instruction to colleges and universities. The bill has a list of concepts related to race, sex, nationality, color and ethnicity that it defines as divisive and therefore prohibited. It does say that divisive or controversial concepts can be taught if done so objectively and impartially, but who gets to determine what is objective or impartial is unclear.

The Ohio Council for the Social Studies (OCSS) firmly opposes both HB322 and HB327 for the following reasons:

These bills are contrary to the purpose of social studies education. Passage of these bills would—whether out of real or perceived threat—stifle classroom discussions, impair critical thinking, dampen creativity, and impose restrictions on the very freedoms needed to obtain civic competency. The value of learning about issues and relevant topics from multiple perspectives would be severely compromised and eliminated, having a disproportionate and undue impact on marginalized groups.

HB322 and **HB327** would impose penalties on teaching standards required by the state

on teaching standards required by state of Ohio and the College Board. Passage of these bills will hinder the ability of students to earn Advanced Placement (AP) credits and access college entrance.

These bills alternatively discourage (322) the discussion of anything "controversial" and outright prohibit "divisive" topics (327) or those that might cause one to "feel discomfort, guilt, anguish, or any other form of psychological distress on account of and individuals race or sex" (322) or that one by virtue of their nationality "bears responsibility for actions committed in the past by other members of the same nationality." (327) These limitations and prohibitions would in turn limit societal understanding to few viewpoints.

HB322, HB327 would not allow class credit for students who advocate for or against a particular public policy. Student engagement would diminish as student agency is eliminated.

A source of pride in Ohio—autonomous local board decision making—would be severely diminished. These bills would handcuff college and university —based Ohio teacher preparations programs in their responsibility to meet accreditation standards. These bills contradict and prevent the execution of existing educational policies and norms.

HB322 and **HB327** violate democratic virtues classroom educators are expected to teach. They are hostile to a student's legitimate social studies education.

SUMMARY-HB322

- With respect to a course in history, civics, or a similar subject areas, prohibits public schools and state agencies from(1) requiring the discussion of current events,(2) requiring or awarding course credit for lobbying or other work surrounding social or public policy advocacy, and (3) accepting private funding to develop curriculum, purchase course materials or provide training.
- Prohibits a state agency or public school from teaching any administrator, teacher, staff member, or employee to adopt or believe in any of the specified concepts.
- Prohibits the State Board of Education from adopting any model curriculum regarding specified concepts.
- Prohibits any teacher or administrator or any employee of a public school or state agency from approving, making use of, or carrying out standards, curricula, lesson plans, textbooks, instructional materials, or instructional practices that serve to inculcate specified concepts.

SUMMARY—HB327

- Prohibits school districts, community schools, STEM schools, state agencies, and state institutions of higher education from teaching "divisive concepts" or accepting private funding to further promotion of "divisive concepts."
- Requires the Department of Education to withhold funding from a school district of school that violates the bill's provisions until such time as the district or school complies.

HB327 summery continued

- Requires the administrative head of each state agency to review its grant and training programs as well as ensure and encourage compliance with the bill's provisions by its employees.
- Requires the Department of Administrative Services to adopt a policy that complies with the bill's provisions and establish rules for the implementation and enforcement of that policy.

Ohio Department of Health: Stay Connected

Due to the COVID-19 emergency, older adults are at a heightened risk of crontacting this disease and having more serious complications. We know that the issues of isolation and loneliness may increase as family members assume their normal routines. Isolation can have serious emotional impacts on any of us, but especially on older adults. During a time when physical distancing has become necessary, many older Ohioans are finding it harder that ever to feel connected to the world and people around them.

This is why the Ohio Department of Aging created the Staying Connected Check-in Service. The Staying Connected service provides a FREE, daily check-in by phone for Ohioans age 60 and older. This service provides comfort and can connect you with aging network information and support. It is easy to get started. Explore the resources below to learn more.

Check-in calls will be made from 7 a.m.-6 p.m. daily. You choose the time that suits you. You can place a hold on these calls at any time.

Who can participate?

- 1. Ohio residents 60 years of age or older who:
 - 1. Have a valid phone number (mobile or land line)
 - 2. Provide an alternate contact (preferred-not required)

How it Works:

- Three attempts will be made to contact you. When you respond you have three options:
 - 1. Confirm you are OK
 - 2. Transfer to learn more about aging services in your area
 - 3. Connect for a friendly chat
- 2. If you do not answer after three attempts:
 - 1. An attempt will be made to reach your alternate contact, if one was provided.
 - 2. A live call will be placed to you and your alternate, if one was provided
 - 3. Notification to local non-emergency service (e.g. sheriff's office) if live call failed to connect.**
- ** This is not an emergency service. If emergency, call 9-1-1.

Signing up is quick and easy. The service is for Ohio residents age 60 and older.

To sign up you will need the following information:

- Your name, year of birth, street address, phone number, and email (if available)
- The name of an alternate contact, relationship to you and their phone number
- ♦ Your preferred one-hour contact window between 7a.m. and 6p.m.
 - **Participant must be prepared to receive and respond to a phone connection test as part of the registration process.**
