LEGISLATIVE: Tom Moscovic reported on the following:

- HB 583 The Ohio House of Representatives passed HB 583 this week. The bill now
 moves to the Ohio Senate. It permits people with a college degree to obtain a one-year
 substitute teaching license.
- Redistricting is still in limbo. There will have to be a second primary election, probably in August.
- Vote for Rita Walters on the STRS Board. Teachers need to have a responsible OEA member on the board. Rita helped make the COLA happen and will be responsible with the use of funds in the future.
- There will be a 3% COLA beginning in July for retirees that are eligible. For qualified retirees it begins the month that the person retired.
- A change was made so that active members will be able to retire at any age with full benefits after 35 years of service.

MEMBERSHIP: New members include Mary Ann Horn, Jan Koerwitz, Joyce Ristau, and Thora Scott. Members are urged to talk to those ready to retire and encourage LCRTA membership.
