Social/Travel: Lynn Miller reported on the following events:

Legislative: Tom Moscovic reported on the following:

- Too much tax money is going to private/church schools, which takes money away from public education.
   There is a lawsuit going on to prevent this. Most school levies failed in the Ohio primary. Dan Troy is a friend to public education.
- SB #168 OEA opposes this for the following reasons: It would allow employment of unlicensed teachers,
  prohibit giving preference to seniority in nonteaching employee staffing reductions, require courses to be
  taught outside the normal school day, change the teacher evaluation framework, and determine the number
  of professional development hours a teacher must complete regarding dyslexia.
- Some other bills to watch: HB #339 vouchers; HB #445 release for religious instruction; SB # 162 use of outside vendors to catch students up.
  - SB #83 higher education not allowed to strike; HB #168 prevent gender affirming care for minors.
- Some bills that are good: HB #407 voucher accountability; HB #408 every student is allowed to eat lunch even if cannot pay; HB #411 raise the minimum pay to \$50,000; HB #387 release East Cleveland and Youngstown schools from state control.

Newsletter: Karen Sawitke stated that articles are due on May 10th.

**Scholarship:** Tim Niederkorn reported that there were 9 completed applications. The committee will meet on April 12<sup>th</sup> to select the finalists. Interviews will take place on April 17<sup>th</sup> and 18<sup>th</sup>. The scholarship winners will be notified on April 19<sup>th</sup>.
