LEGISLATIVE: Tom Moscovic reported that STRS did not raise money for the audit. Tom also mentioned the following House Bills.

- HB #1 To create a new school finance system is on the back burner.
- HB #110 The budget must be completed by June 30th. The question is whether to include HB #1.
- HB #200 Whether to eliminate A-F letter grades on the state report card.
- HB #54 To dissolve academic districts commissions and to instead require improvement plans for low-performing schools.
- HB #99 To address requirements for school staff to carry firearms.
- HB #151 To replace the Ohio Teacher Residency Program with local new teacher mentorship programs.

Gov. DeWine has proposed funding for "Wraparound" services that would give support to programs such as after-school programs, mental and physical health services, and aid for students that are behind.

Tom reminded members to vote in the STRS election. Members can vote by mail, online, or by phone. If trouble voting online, call the phone number listed. OEA endorsed Robert Stein and Rita Walters.

SCHOLARSHIP: Tim Niederkorn reported that LCRTA has received 16 applications. The committee will score the applications by April 23rd. Interviews for the top candidates will be held May 4th and 5th and the winners will be notified on May 5th. Tim thanked all members that donated to the Scholarship fund.
